





Contest Corner

Some discussion has arisen recently in judging during NMRA contests. Generally the complaint has been that the judging has been inconsistent from Division to Region to National. Let me address some of these issues.

First, there will be some variation in judging as people (judges) vary from contest to contest. This is only natural. As a modeler, take a hard look at your model. Is it cleanly constructed? Are all the details there, and are they well executed? Is the finish done well and realistic? Be honest with yourself.

Judging at the Divisional level is usually more lenient to encourage modelers. The ranking of first, second and third is not affected by the scoring. The top points are first, the second highest score is second, etc.

Models at the National level will be far more competitive than at the local level because you are competing with models from all over the world rather than a local area. The judges are more critical, as they do not overlook items that may be missed at the Division level. At the Anaheim meeting, the judges were briefed on judging procedures and all judging teams were led by a Master Model Railroader. A model that wins first at a Division Meet may not place at the National NMRA Convention.

During judging all judges are asked to make comments on extra forms to explain their scores. A glue spot may not make that much difference at the Divisional level but will at the national level when all the other models do not have any glue spots.

Finally, if you have a question or comment, see your Divisional level AP Manager or Contest Chair first. Then go to Regional and finally National. Understand that those at National are a bit removed from the specific situation and will come back to the Regional and Divisional level to understand the situation. When conversing, please be polite, even if you are unhappy with the situation. Irate communication does not help your cause. Provide objective information and as much factual information as possible.

As Ben told you in the last issue of the Dispatch, I have agreed to assume the Contest Chair position for the PSR. I'm not exactly a neophyte at this because I have held the AP/Contest Chair position in the Cajon Division for a while. I sort of learned from the school of hard knocks-if you know what I mean.

I think the first order of business is to express, for all of us, our appreciation to Duane Buck for holding this position for so long and doing such a great job. I know that he has helped me significantly in this transition.

I have found that one of my responsibilities is the maintenance of the PSR Contest Directory, the guidance document for conduct of contests in the Region. I plan to update the Directory, have it reviewed by the Contest Committee, and in the hands of the PSR Board about three weeks prior to the Temecula meeting, where it can be considered for approval.

You'll notice that I said "Contest Committee" in the prior sentence. The Contest Committee consists of the four Divisional Contest Chairmen. We are now trying to determine the functions that the committee needs to perform on a regular basis. I tend to think that one of the prime functions of the committee will be the recruitment and training of quality judges for the contests. I believe that the reason we hold contests is so that the membership can advance in the Achievement Program. The idea is to give good feedback to the modeler so that he, or she, can improve their skills and I hope that's just what we do.

Amador, Truckee & South Fork Railroad

“Serving the Mother Lode”

The Amador, Truckee & South Fork RR is the first model railroad I have built, after 50 years of armchair “dreaming”. It is approximately 16 feet by 16 feet, occupying half of a three-car garage in Carlsbad. My wife Lise is an active partner in building the layout.

Background: Fictionalized Reality

The Amador, Truckee & South Fork Railroad, called “the South Fork” for short, is a fictional line set in a real location: the Sierra Nevada mountains east of Sacramento. The South Fork serves the lumber, gold mining and agricultural industries in the region, and crosses the Sierra Nevadas just south of Lake Tahoe to interchange with the Virginia & Truckee Railroad at Minden, Nevada. The South Fork line to Minden provides passenger service to resorts at the south end of Lake Tahoe, especially in the summer.

While the setting is real, the railroad is entirely made up. The names of towns were selected for their “Western” flavor, with little or no regard to their true geographical location, although most have one or more namesakes in the Sierra Nevada region.

The railroad’s name derives from the region it serves: from Amador County to the area between the Truckee River and the South Fork of the American River. The name was designed to allow locomotives and equipment with Atchison, Topeka and Santa Fe RR lettering (but without the name spelled out and without the Santa Fe herald) to operate as South Fork equipment. The AT&SF markings also pay a tribute to the Santa Fe, which employed my grandfather and great-uncle as Conductors and my uncle as an Engineer.

The South Fork was, in theory, created by a merger of several small railroads in the Sierra Nevadas, including the real but now gone Camino, Placerville & Lake Tahoe RR. As a cobbled-together line, the South Fork operates on two mainlines out of its base at Charlottesville, California, a fictional town (named for my daughter) located on the Southern Pacific mainline near Sacramento. One line runs roughly along the path of California Route 50 over the mountains to Minden, Nevada. This line is represented by the track running to the left out of Charlottesville into a tunnel, and Minden and all points in between are located “in the tunnel”, where a reversing loop and some staging tracks allow a variety of trains to exit and enter Charlottesville on this line. The other line leaves Charlottesville to the right

and runs up steep grades (up to 4%) on the western slope of the Sierra Nevadas through Indian Wells, splitting at Nevada City Junction into branches to the city of Sierra via Mosquito Gulch, and to Nevada City via Gold Hill. Sierra Timber Company Railroad

The Sierra Timber RR is a logging line which runs from Sierra, where it interchanges with the South Fork RR, up to a logging camp at Fish Hook (logger humor meaning “at the end of the line”). The S T RR’s lone Shay hauls logs down to Sierra and dumps them into the log pond at the saw mill, and provides some service to ranchers along the line.

The Setting

It is the fall of 1955. The new Chevrolets have arrived at the dealer in Amador City, and the popular cars are showing up everywhere in the area served by the South Fork. Steam still rules the Amador, Truckee & South Fork RR, but a second-hand GE 44-ton switcher has been purchased for yard operations in Charlottesville and Gold Hill, and a diesel switcher has been leased from the Southern Pacific for testing on the steep grades and sharp curves of the South Fork. South Fork management is trying to decide if an investment in diesels, purchased second-hand of course, would result in sufficient savings in operating and maintenance costs to justify the expenditure. The decision is crucial, since declining traffic from the gold mines and lumber camps and increased competition from trucks have cut deeply into the South Fork’s historically narrow profit margins. Lights burn late in the South Fork’s General Offices above the depot in Charlottesville.

South Fork Operations

The layout is designed for operations: trains running from one place to another, with challenging switching opportunities along the line. In this, I have been strongly influenced by Dick Trotter’s Coyote Pass and Northern RR and Dick Roberts’ Nevada Country Railroad layouts, and by my club: the North County Model Railroad Society.

Trains generally operate point to point from Charlottesville to Minden (hidden reverse loop), Sierra or Nevada City. Sierra and Nevada City are scenically one and the same place: they share a station, track and a turntable. But operationally they are two different places. Trains arriving from one direction at Sierra or from the other at Nevada City can switch only the

industries “in their city”. Sierra has the saw mill, the interchange with the logging line, and a railroad supply storehouse. Nevada City, which serves an agricultural community, has an oil dealer, freight house, feed mill and farm supply company. Trains operating in each city can use the mainline, runaround track and turntable.

Trains can arrive at Sierra or Nevada City ONLY after they have passed the flagstop station at Nevada City Junction. Since the flagstop is on the leg of a wye which is not accessible to trains climbing upgrade from Charlottesville, trains have to complete a lap around the upper level of the layout to pass by the Nevada City Junction flagstop station. This feature lengthens runs. To avoid having trains that have not passed Nevada City Junction rolling past their destinations at Sierra or Nevada City en route to the junction, trains must take the Copenhagen Cutoff (I thought of the cutoff while visiting Copenhagen), which bypasses Sierra and Nevada City. Once a train has completed a lap in either direction using the cutoff and has passed the Nevada City Junction flagstop station, it can proceed to its destination: Sierra or Nevada City.

Progress on the layout has been slow because we travel a lot, but it is operational. My wife Lise has built several outstanding structures with scratch-built, detailed interiors. Some scenery is in place. I am proceeding with the philosophy that the big tasks need to get done, and I can go back later and add details, weather structures and rolling stock, etc. I sometimes call the railroad “The Good Enough Central”, but what I am striving for is a layout that, when taken as a whole, is a pleasure both to look at and to operate.

Dan and Lise are active members of the San Diego Division in between their trips to various places around the world. Dan is involved in operations on several layouts in the San Diego area, and is an accomplished modeler. Lise enjoys structure building, and has entered her work in local contests.

Dan submitted this article in response to my request for articles from PSR members – I’m sure you have an interesting story or description of your layout, models or activities in the hobby. I look forward to seeing it soon!
